CBC 11B-202.4 Regulates accessibility requirements when alterations or additions are being made. When alterations or additions are made to existing building or facilities, an accessible path of travel to the specific area of alteration or addition shall be provided. The primary accessible path of travel shall include; a primary entrance to the building or facility, toilet and bathing facilities serving the area, drinking fountains serving the area, public telephones serving the area, and signs. Work within the area of work is not to be considered a part of accessibility improvements to the path of travel.

When the construction cost is less than or equal to the current valuation threshold of \$186,172.00, the cost of compliance shall be limited to 20 percent of the construction cost of alterations, structural repairs or additions. When the cost of full compliance would exceed 20 percent, compliance shall be provided to the greatest extent possible without exceeding 20 percent.

In choosing which accessible elements to provide, priority should be given to those elements that will provide the greatest access in the order given below.

The following costs shall include detailed estimates for all elements and shall be attached to this form:
