No special accommodations are available to individuals with any condition that may limit them from participating in the hearing. If you require any assistance, please plan to provide it.

Hearings are conducted at the Atascadero Police Department, 5505 El Camino Real, Atascadero, CA.

#### PLEASE BE ADVISED THAT:

- 1. The registered owner of the vehicle in issue is required to attend unless responsibility has been transferred via timely affidavit of non-liability per CVC 40209/ CVC 40210.
- 2. The Lieutenant will decide only the citation/s that are prepared for hearing at this time.
- 3. An original or true copy of a citation that contains all material information is sufficient to establish that the violation occurred, unless disproved by evidence to the contrary. The issuing officer will not be required to be present at the hearing.
- 4. You have the obligation to show by a preponderance of the evidence (that is, by evidence that has more convincing force and the greater probability of truth than that opposed to it) that the citation in question was not validly issued. Such evidence may include, but is not limited to, records, documents and/or testimony of witnesses. Bring all of your evidence with you. Your hearing cannot be continued to obtain additional evidence.
- 5. You are to remain in the hearing room until your hearing is completed. If you should fail to appear or leave prior to the completion of your hearing, you will be considered in default and a decision will be made on the evidence already in the record.
- 6. You have the right to seek review of the final determination of the Lieutenant within 30 calendar days from the mailing of the Lieutenant's decision by filing an appeal with the San Luis Obispo Superior Court per CVC 40230.
