Incomplete submittals will not be accepted

Note: A building permit is required for all free-standing flagpoles when greater than 20 feet in height or when illuminated.

Complete Application: Must be signed by Owner, Agent (with approved written authorization), or Licensed C-45 Contractor

Include height of flagpole on application. Flagpoles may be allowed up to a maximum of 50 feet in height per AMC Section 9-4.113

Permit Fee:

- Wall Sign = \$ 75.00 cash/check (this review can be done at an Over the Counter Appointment; call 805-461-5035 to schedule)
- Residential Flag Pole = \$ 75.00 cash/check
- Monument (Stand-alone); Commercial Flag Pole = Current Express Permit Fee

Site Plan - 2 Sets (monument signs & flagpoles only): Show topography, drainage, rear, front and side setbacks, walkways, driveways, easements, location of any native trees with dripline within 20' of any construction/activity, location of all structures, and location of sign or flagpole.

Flagpoles:

- Accessible paths of travel associated with any walkways and paths on public and commercial properties
- Proximity to any overhead wiring

Construction Drawings – 2 Sets:

- Signs:
 - Wall Mounted Sign: Show how the sign is mounted and/or supported.
 - **Monument Sign:** Complete plans and details. If base is 4 foot or greater, from bottom of footing to top of sign, structural and foundation sheets must be stamped and signed by a licensed architect or engineer.
 - **Illuminated Sign:** Provide a single line schematic drawing of the system and show location of the disconnect.
 - **Sign Dimensions:** Provide dimensions in square feet for all proposed signs.
 - Colors
- > Flagpoles:
 - **Foundation design** (stamped and signed by a licensed architect or engineer)

Lighting Compliance: All lighting must be shielded in compliance with AMC Chapter 9 §137

Grant Deed / Title Report: Required if applicant name is different than County Assessor's records.
