The contractor must be licensed for the type of work to be performed. "A" Licensed General Engineering Contractors can perform all work in the public right-of-way. A current City business license must be maintained. <input type="checkbox"/> Engineering Standards	<ul style="list-style-type: none"> Encroachment permit work must conform to City Engineering Standards and Standard Specifications, unless alternate plans are approved. Applicants should reference specific standards in their plan submittal, or the City will add this info to permit conditions. 	required	required	required	required
<input type="checkbox"/> Tree Removal Permit	<ul style="list-style-type: none"> Contact Community Development at 805-461-5035 to determine if a tree removal permit is required.
